DOG/CAT LICENSES

Annual dog and cat licensing renewal is due in January. As of February 1 a monthly late fee of \$5.00 per animal will apply. Please notify the license official if you no longer have your dog or cat at 735 - 4107, ext. 108.

A dog license is \$8.00 if the animal is spayed/neutered, \$11.00 if not spayed/neutered.

A cat license is \$8.00 if the animal is spayed/neutered, \$11.00 if not spayed/neutered.

To acquire an animal license, please send the following;

- ▶ proof of spaying/neutering, if applicable
- ▶ check made payable to the Township of Bethlehem
- ▶ proof of rabies vaccination (must be valid through November 1st)
- ▶ a self-addressed stamped envelope for the return of the license
